The Department of Environmental Quality/Water Quality Division (DEQ/WQD) is revising Water Quality Rules and Regulations Chapter 25, Septic Tanks, Soil Absorption Systems, and Other Small Wastewater Systems. DEQ/WQD is surveying manufacturers from our Approved Septic Tank list to determine the impact of these proposed changes. Proposed changes which could potentially affect tank manufacturers are located in Section 9, Septic Tanks and Other Treatment Tanks.
