BROOK MINE'S BRIEFS EXPLAINING WHY ITS MINE PLAN WILL NOT SUBSTANTIALLY PROHIBIT THE OPERATIONS OF PADLOCK RANCH AND BIG HORN COAL COMPANY

Following a two-day hearing, this Council asked the parties to brief their arguments and evidence on **the third element** for an order in lieu of consent: the use does not substantially prohibit the operations of the surface owner. Wyo. Stat. Ann. § 35-11-406(b)(xii)(C). Brook has attached two separate briefs to address the element as it applies to Padlock Ranch and Big Horn Coal Company. Brook has split its briefing for two reasons. First, the arguments and evidence differ for why Brook will not prohibit the operations of either surface owner. Second, the Council will have to vote twice and issue **two decisions**, one for each surface owner. So it made sense to address each separately.

Brook has also attached findings of fact and conclusions of law, including a proposed order for each landowner. The Attorney General's office representative suggested this as a

possible course of action. Although the Council did not specifically ask for it, Brook has included the proposed findings as a courtesy to the Council should it want to sign those findings and proposed order.
