ORDER DENYING REQUEST FOR ORAL

ARGUMENT AND MOTION TO STRIKE

Powder River Basin Resource Council has requested that the Environmental Quality Council (Council) have oral argument on and decide the applicability of Wyo. Stat. Ann. § 35-11-406(n) prior to the parties filing their proposed findings of fact and conclusions of law. The briefs recently filed by the parties have sufficiently addressed the issue of whether Section 406(n) is applicable and I find no need for

oral argument on that issue.

Further, the Council will not decide the applicability of Section 406(n) prior to the parties filing their proposed findings of fact and conclusions of law. As stated in my June 13 Briefing Order, the parties' proposed findings of fact and conclusions of law must focus on the law that is applicable in this matter, which necessarily includes whether a party believes Section 406(n) is applicable. The Council will not, prior to receiving the proposed findings of fact and conclusions of law, decide that legal issue.

The Council will consider that legal issue during its deliberations in this matter.

Powder River Basin Resource Council has also asked the Council to strike Brook Mining Company, LLC's reply briefs filed on June 30 for being duplicative and failing to comply with my order dated June 13, 2017. Although filing three reply briefs instead of one was not necessary and may be duplicative, I am denying the motion to strike.

THEREFORE, Powder River Basin Resource Council's motions are DENIED.
