Dear Mr. Crossingham;

On June 15, 2017 Mr. Gibson provided to you copies of the mining plan, reclamation plan, a Surface Landowner's Consent Form, map and other materials relating to the Herco Amendment to Permit to Mine No. 248C, with a request that you review the materials and return the signed Form 8, all in compliance with W.S. §35-11-406(b).

The Herco Amendment covers the following property in T41N, R81W:

Section 2: SE1/4SE1/4

Section 11: E1/2

As you are aware, on March 19, 2014, Herco Minerals, LLC quitclaimed to BHB the minerals in the SE1/4SE1/4 of Section 2, and the NE1/4NE1/4 of Section 11. Nevertheless, we have included a copy of the deed herewith.

As to the remainder of the NE1/4 of Section 11, you assigned to BHB "all of your right, title and interest in and to the bentonite in, on and under" the TTT #10 mining claim with the "right to use and occupy the Mining Claims as reasonably necessary for mining operation thereon without payment of additional fees or surface damage payment." Black Hills has honored the Assignment by continuing to make annual payments of \$15,000 to you since it was signed in July, 2013. Again, we have included a copy of the Assignment.

Finally, with respect to the SE1/4 of Section 11, BHB has received ownership of the Bobcat #10 Placer Claim that was located on May 18, 2008 and later recorded, all of which is of public record.

BHB asked that I make one last request of you to cooperate by signing Form 8. As we have previously discussed, time is of the essence since the Assignment terminates in 2020. BHB has instructed us to file a petition with the Environmental Quality Council for an Order in Lieu of Landowner Consent if BHB does not receive a signed Form 8 from you by August 31, 2017.
