## MEMORANDUM OF GRANT OF EASEMENT AND RIGHT-OF-WAY

This Memorandum of Grant of Easement and Right-of-Way is an abstract of the agreement made between TTT Ranch Co., a Wyoming corporation, 1203 TTT Road, Kaycee, Wyoming 82639 herein called Landowner, and Black Hills Bentonite, LLC, a Wyoming limited liability company, whose address is Box 9, Mills, Wyoming 82644, herein called Black Hills.
