Hearing Request for Rules of Practice and Procedure, Chapter 1

The Department of Environmental Quality (Department) is proposing revisions to the Rules of Practice and Procedure Chapter 1 and is requesting the Environmental Quality Council (Council) review the proposal and consider adoption of these rules at your November 6, 2018 hearing.

The Department initiated the revision of the Rules of Practice and Procedure, Chapter 1, General Rules, with a public notice and comment period related to the September 22, 2017 Water and Waste Advisory Board (WWAB) meeting, at which the WWAB recommended adoption of the rules to the Council.

The Department also published a public notice and opened a comment period related to our presentation of the proposed revisions to the Land Quality Advisory Board (LQAB) at their December 6, 2017 meeting, at which the LQAB recommended adoption of the rules to the Council.

Lastly, the Department published a public notice and opened comment periods related to our presentation of the proposed revisions to the Air Quality Advisory Board (AQAB) at their December 12, 2017 meeting and at their April 27, 2018 meeting. The AQAB convened a special meeting on July 12, 2018 to further discuss the proposed revisions and on that date recommended adoption of the rules to the Council.

Upon receipt of the AQAB recommendation, the Department sought and has been granted approval by the Governor's Office to proceed with the proposed rule.
