- 2. On September 21, 2019, the parties negotiated a settlement agreement and resolution of NOVO 5908-19.
- 3. Because Riverside and DEQ/WQD have amicably resolved NOVO 5908-19, the parties jointly move to dismiss the appeal of that NOVO. A proposed order is attached.
