If the administrator finds there is a significant degree of public interest they may facilitate a public meeting. The DEQ/WQD considers all comments when making final permit issuance or denial decisions, these decisions are appealable to the Wyoming Environmental Quality Council (EQC). All comments shall be received in writing via fax, or electronically through the DEQ's public comment portal by 5:00 pm on August 16, 2021. Comments received by email shall not be accepted.
