## STIPULATED MOTION TO DISMISS WITH PREJUDICE

**COME NOW**, Vaquero Big Horn, LLC ("Vaquero"), and the State of Wyoming, Department of Environmental Quality, Water Quality Division ("DEQ") by and through their respective counsel, and hereby move the Environmental Quality Council ("Council") for an Order dismissing this matter with prejudice. In support of this motion, the Parties state as follows:

- 1. On November 23, 2021, Vaquero appealed from Wyoming Pollutant Discharge Elimination System Program ("WYPDES") Permit No. WYW002731, issued by DEQ on October 26, 2021 ("2021 Permit Renewal"). The 2021 Permit Renewal authorizes discharges associated with an oil production treatment unit located on State 30 Lease 70-1284 in the SW of Section 30, Township 48 North, Range 103 West Park County ("Facility").
- 2. The Appeal included a request to stay the 2021 Permit Renewal, to allow Vaquero to operate the Facility under the terms and conditions of the 2016 WYPDES permit

pending resolution of the appeal. DEQ did not oppose Vaquero's request to stay the 2021 Permit Renewal. On January 13, 2022, the Council issued an order granting Vaquero's Request for Stay of the 2021 Permit Renewal.

- 3. On March 11, 2022, the Council issued an order granting the parties' Request for Stay of the Appeal until the effective date of the Permit Modification. The Order Granting Stay required that the parties file a stipulation of dismissal with prejudice within ten days of the effective date of the Permit Modification.
- 4. DEQ issued the final Permit Modification on July 15, 2022, accordingly, the parties now file this Stipulated Motion to Dismiss.

WHEREFORE, the parties jointly request the Council enter an order dismissing Vaquero's Appeal with prejudice. A proposed order granting the motion to dismiss is attached.
