2	(Meeting proceedings commenced
3	9:00 a.m., November 15, 2022.)
4	CHAIRMAN LENZ: Good morning. I'm Steve
5	Lenz, and I'm the chairman of the EQC. Today is
6	November 15, 2022. It's 9:00 a.m. at the Capitol Extension
7	Public Meeting Room 5 in the Herschler Building, 122 West
8	25th Street, Cheyenne, Wyoming 82002 and via Zoom
9	conferencing.
10	Solid Waste Rule Chapter 3 Council members
11	present today are Shane True, Marjorie Bedessem, Stan
12	Blake, Ryan Greene, John Corra, and myself. And Council
13	Member J.D. Radakovich is on Zoom.
14	Council staff present today are Jim Ruby, Joe
15	Girardin, and Ryan Schelhaas, the EQC counsel from the
16	Attorney General's office.
17	This meeting is now called to order. At this
18	time, I would ask for a motion to approve the minutes from
19	the September 13, 2022, meeting.
20	COUNCIL MEMBER BLAKE: I make that motion
21	to approve those minutes of September 13th.
22	COUNCIL MEMBER CORRA: I'll second.
23	CHAIRMAN LENZ: Okay. We have a motion and
24	a second. We will take a voice vote. All in favor, say

2	CHAIRMAN LENZ: Opposed. Motion passed.	
3	We have two rulemaking packages scheduled for	

- 4 this hearing today. The first rulemaking is Docket 22-5102
- $\,$ 5 $\,$ from the Solid & Hazardous Waste Division, proposed to
- 6 revise Chapter 3 of the Solid Waste Rules.
- 7 The hearing officer for this hearing is Council
- 8 Member Greene, and I'll turn the gavel over to him at this
- 9 time.
- 10 COUNCIL MEMBER GREENE: Good morning. I am
- 11 Ryan Greene, the hearing officer in Docket 22-5102. It is
- 12 November 15, 2022, and this hearing is being held at the
- 13 Capitol Extension Public Meeting Room 5, Herschler
- Building, 122 West 25th Street, Cheyenne, Wyoming 82002,
- 15 and via Zoom videoconferencing.
- 16 Council Members present today are J.D. Radakovich
- 17 via Zoom, Shane True, Steve Lenz, Stan Blake, Marjorie
- 18 Bedessem, John Corra, and myself.
- 19 Counsel staff present are Jim Ruby, Joe Girardin,
- 20 and Ryan Schelhaas, the EQC counsel from the Attorney
- 21 General's Office.
- 22 For those of you who wish to testify during
- 23 public testimony on this package, I will call for the
- 24 testimony in the following order. Those in support who are
- 25 present here, and then those who are in support that are on

- 1 video and audio. Then testimony in opposition who are
- 2 present here, and then those who oppose that are on video.
- 3 And then, finally, testimony in a neutral capacity.
- 4 If you wish to testify through Zoom, please click
- 5 the raise your hand button, and I will ask for your
- $\,$ 6 $\,$ testimony, and I will call on you to give your testimony.
- 7 The Council will have the opportunity to ask
- 8 questions of anyone who testifies. The Director of DEQ or
- 9 his designee will also have the opportunity to ask
- 10 questions.
- Would the representatives from the Department
- 12 please come forward, state your name, and spell it for the
- 13 record.
- And before you begin, would you like us to ask
- 15 our questions as we go along or save them until the end?
- MS. WEIKART: Mr. Chairman. If you would
- 17 save your questions for the end, I would appreciate that.
- 18 I'm Jody Weikart. Jody, J-o-d-y, Weikart,
- 19 W-e-i-k-a-r-t.
- MS. BUDINE: I'm Nicole Budine from the
- 21 Attorney General's Office, and N-i-c-o-l-e B-u-d-i-n-e.
- 22 COUNCIL MEMBER GREENE: Thank you. And
- 23 please proceed.
- MS. WEIKART: Thank you, Mr. Chairman.
- Good morning, Council Members. My name is Jody

- 1 Weikart. I'm the solid waste permitting and corrective
- 2 action program manager. You see an empty seat next to me
- 3 today because Administrator Engels is feeling a little
- 4 under the weather. And she does send her regards to the
- 5 Council and wishes that she were here today.
- As mentioned, I'm here to present the rule
- 7 package for the revised Solid Waste Rule Chapter 3,
- 8 Industrial Landfill Regulations. And at the end, we'll be
- 9 seeking approval for the revised chapter and the Statement
- 10 of Principal Reasons by the Council.
- 11 This rule was last looked at 24 years ago, in
- 12 1998. We've come a long ways since then. And so we worked
- 13 collaboratively with the Attorney General's Office and also
- 14 the Wyoming Solid Waste & Recycling Association, WSWRA.
- The Attorney General's Office helped us quite a
- 16 bit with readability, structure with the rules, and
- 17 grammar. We also worked with WSWRA, as I mentioned. We
- 18 reached out to their membership at their annual conference
- 19 in 2021. And we also held a board meeting with them to
- 20 discuss the changes in detail in 2021.
- 21 This rule has been through three public comment
- 22 periods. Back in February of this year, we had an informal
- 23 comment period. We received one comment from the Wyoming
- 24 Solid Waste & Recycling Association in support of this
- 25 rulemaking effort.

- 1 We then had another 30-day comment period in May
- 2 of this year, prior to the June Water and Waste Advisory
- 3 Board meeting. We received no comments. The Board did
- 4 give us some suggestions, revisions, which we incorporated
- 5 into the version of the rule presented today.
- 6 The Board commended the Department on working
- 7 with stakeholders to the point that no comments were
- 8 received except for one comment in support during the
- 9 informal public comment period. And they also commended
- 10 the Department on the rule package that was provided and
- 11 the presentation that was given.
- And then prior to today's hearing, the rule went
- 13 through a 47-day public comment period in September and
- 14 October. And, once again, we received no comments.
- 15 The goal of this rulemaking was to streamline the
- 16 rule, provide consistency with other solid waste rules, and
- 17 remove the requirements of CCR landfills to be permitted
- 18 under Chapter 3, as they are now permitted under Chapter
- 19 18, which was a rule adopted by the Council in June of this
- 20 year.
- 21 Some of the highlights of our rulemaking. We
- 22 removed redundant and unnecessary language for clarity and
- 23 consistency. So, for example, rules and regulations, we
- 24 shortened that to just rules.
- We reorganized the rules so it was structured

- 1 consistently with other solid waste rules. So if you were
- 2 to look at Chapter 2, our Municipal Solid Waste Landfill
- 3 Rule; Chapter 4, our Construction Demolition; and Chapter
- 4 6, our Transfer, Treatment, and Storage Rule, you'll see
- 5 that Section 3 is General Facility Information. If you'll
- 6 look at the revised Chapter 3, Section 3 is General
- 7 Facility Information. We thought this would give our
- 8 facilities an easier time navigating all of our rules.
- 9 We corrected capitalization, references, and
- 10 grammar. For instance, Administrator, we made sure that
- 11 was capitalized.
- We also updated our references, because, as I
- 13 mentioned, this rule was last looked at in 1998, and almost
- 14 all of our rules has been revised since then. And so we
- 15 corrected all those references.
- 16 We also updated language so that our rules would
- 17 be consistent with each other. And so, for example, in
- 18 Section 3 of the revised Chapter 3, manager information is
- 19 required. That was required previously. We just updated
- 20 the language so it would be consistent with that language
- 21 in our other rules.
- We eliminated the separate requirement for
- 23 industrial landfills of less than one acre. Now all
- 24 industry landfills must meet the same requirements in the
- 25 rule.

- 2 permit terms through post-closure. That transition will
- 3 take place when existing facilities renew their operating
- 4 permit. They will renew for a lifetime permit through
- 5 post-closure. And any new facilities will receive a
- 6 lifetime permit when they receive their first operating
- 7 permits.
- 8 We've also added annual reports because of that
- 9 lifetime permit. And, finally, we created some new
- 10 sections. Sections 14 through 17. Those were all created
- 11 to provide clarity for the applicability of other solid
- 12 waste regulations. Some of our facilities have dry pads or
- 13 they need to solidify material before it's placed for
- 14 disposal, and so that would be a transfer, treatment,
- 15 storage operation, and so they need to meet those
- 16 regulations. So we just clarified that with these new
- 17 sections.
- So while all those revisions sound wonderful,
- 19 what does that mean for a permit? What does a permit look
- 20 like? If you were to open one up on your desk today, what
- 21 would you find in it?
- So our industrial landfill permit, you're going
- 23 to find general facility information. This is going to be
- 24 information on the operator and manager. It's going to be
- 25 the service area, what waste they accept, their lifespan,

- 1 the facility's capacity.
- 2 You'll also see information on the location of
- 3 the facility. We have a lot of location standards. So
- 4 you're going to see how far they need to be to the nearest
- 5 drinking water well, wetlands, fault zones, those sorts of
- 6 things.
- 7 There will be information on geology, soil types,
- 8 depth to the uppermost groundwater, groundwater flow
- 9 direction. You're going to see a lot of details on the
- 10 design of the landfill. This includes things like the
- 11 buffer zones. They have sufficient cover material, slope
- 12 stability. If the facility is required to line, you're
- 13 going to see that liner design.
- You'll also see information on the operation of
- 15 the facility. Some of this includes the knowledge and
- 16 training that their solid waste manager will have. And it
- 17 will also show how their operation will handle access,
- 18 control, litter, dust, routine cover, those sorts of
- 19 things.
- There will be information on monitoring. You'll
- 21 see sampling analysis plans. You'll see sampling
- 22 schedules. You'll see what monitoring they're doing.
- 23 You'll see their plans for recordkeeping. Our rule
- 24 requires certain records to keep it -- be kept for a
- 25 certain period of time. Those items include litter

- 1 collection, financial assurance documentation, training,
- 2 the permit application itself, the operating permit, permit
- 3 amendments that they receive.
- 4 And since these permits are for the life of the
- 5 facility through post-closure, you're going to see some
- 6 pretty detailed information on closure and post-closure
- 7 care. So that's going to include closure schedule, the
- 8 notice on the deed, design of the final cover, access
- 9 control during post-closure.
- There will be information regarding other solid
- 11 waste chapters. As I mentioned before, some of our
- 12 facilities have drying pads or treatment pads for
- 13 solidification of the waste so they can place it in their
- 14 cell. That would require transfer, treatment, storage
- 15 permit. So instead of issuing a separate permit, they just
- 16 include that information in their Chapter 3 permit.
- Special lease is another item that would fall
- 18 under this.
- And then, finally, you'll see supporting
- 20 documents. These are maps of the facilities, drawings of
- 21 the various designs for the cells, cross-sections, well
- 22 logs, table calculations, that sort of information.
- So with that, that concludes our presentation on
- 24 the rule. And so, Mr. Chairman, we are happy to answer any
- 25 questions you have on the rule at this time.

- 1 COUNCIL MEMBER GREENE: Thank you for your
- 2 presentation.
- 3 Does -- oh, yeah. Question from Council.
- 4 COUNCIL MEMBER BLAKE: Yes. I have a
- 5 question, probably just to educate me.
- 6 When you say lifetime permit, is that lifetime of
- 7 the plant? Is it the lifespan of the facility? So can you
- 8 explain to me what -- lifespan versus lifetime permit, if
- 9 you can. Thank you.
- MS. WEIKART: Mr. Chairman, it is the
- 11 lifetime of the facility. So when the facility first comes
- 12 in for a permit, they will receive a lifetime, and that
- 13 permit will end when the post-closure period for the entire
- 14 facility has been approved.
- 15 COUNCIL MEMBER GREENE: All right. Any
- 16 other questions?
- 17 Council Member.
- 18 COUNCIL MEMBER CORRA: Yeah. Sharp finger.
- Okay. Hi. I had one quick comment, so -- but my
- 20 question -- and it may -- in the -- my question has to do
- 21 with financial assurance. Now, there is -- that is
- 22 contained in another rule. And your reference here is just
- 23 to Chapter 7, I think. Yeah. But -- and so you may -- if
- 24 you can't answer it, I'll understand.
- I was just curious, once there was this concern

- 1 about financial assurance, bonding these landfills, and
- 2 have you -- as you all, as an agency went through and redid
- 3 the self-bonding requirements for mining and so on, did you
- 4 also make changes to the financial assurance requirements
- 5 for landfills? And if you did, can you tell me what they
- 6 are now, or is it not a good question to ask?
- 7 MS. WEIKART: Mr. Chairman. Yes, we did
- 8 make changes to our financial assurance chapter. Those
- 9 were completed last August, I want to say. And we did use
- 10 the Land Quality chapter and the Water Quality chapter as a
- 11 guide for making those revisions. And our bonding group
- worked to make sure that those were consistent throughout
- 13 the departments.
- 14 COUNCIL MEMBER CORRA: Yeah. My comment is
- 15 it's good to see that Solid Waste Recycling Association
- 16 supports you in this effort. When the Department started
- down the road of regulating landfills, way back when, it
- 18 was kind of amazing how fond all these local operators were
- 19 of their own garbage. They just wouldn't let it go. So a
- 20 lot has changed. So good presentation.
- 21 Thank you, Mr. Chairman.
- 22 COUNCIL MEMBER GREENE: Any other
- 23 questions?
- Yes, Chairman Lenz.
- 25 CHAIRMAN LENZ: Thank you, Mr. Hearing

1 Officer.

- 2 So I'm glad that your representation is here from
- 3 the AG Office as well. In reading through this, I came
- 4 across a section under General Facility Information. And
- 5 in your either laptop or your documentation they have there
- 6 -- it's actually on Section 3-17, lines 756 through 764.
- 7 And what came out of that, as I read it, it's talking about
- 8 the operator, and how an operator will play their role in
- 9 this permit. And it has language -- and I spoke with
- 10 Mr. Schelhaas about it as well, and in his research, it
- 11 goes clear back to the 1998 version.
- MS. WEIKART: Uh-huh.
- 13 CHAIRMAN LENZ: But it's asking for
- 14 information about the operator, whether they have had any
- 15 kind of legal infractions. And it includes the words
- 16 felony conviction, court proceedings, criminal
- 17 racketeering, and I assume that's some kind of standard
- 18 language for that. But what came out of it for me was how
- 19 does that then get regulated? Who would be the enforcing
- 20 agency, if that information was voluntarily revealed or if,
- 21 after the permit was granted and this operator was the --
- 22 was approved, and then you found out that they had priors,
- 23 how do you go about suspending, revoking, you know, what
- 24 kind of time lines do they have to get a new operator who
- does not have this kind of background? That may not be a

- 1 question that can be answered.
- MS. BUDINE: I don't -- just push it?
- 3 Okay. Thank you.
- 4 Mr. Councilman, so I have to admit I'm actually
- 5 the stand-in Assistant AG today, because the other one had
- 6 other commitments. But for the purposes of this rule, my
- 7 assumption, based on the Water Quality rules I normally
- 8 work with, that is DEQ, that determines what happens with
- 9 the permit. But I'll let the DEQ representative answer
- 10 that.
- MS. WEIKART: Mr. Chairman. This is
- 12 reviewed at the time of the permit application being
- 13 submitted to the Department. And we do a completeness and
- 14 technical adequacy review at that time. I do know that in
- our Solid Waste Chapter 1, the Director does have the
- 16 ability to revoke a permit if they -- I'm having someone
- 17 pull up Chapter 1 right now to take a look at it. But I do
- 18 know that we have the ability to revoke a permit. It's at
- 19 the Director's discretion.
- MS. BUDINE: Yes. I would agree with that.
- 21 CHAIRMAN LENZ: Okay. Thank you.
- It seemed as though that language was strong, and
- 23 had some serious implications to the facility and through
- 24 the permit. And my curiosity was how would we handle that,
- 25 if that were revealed, either voluntarily or involuntarily.

- 1 And with these being lifetime permits, it seems like it
- 2 could end up with a situation like that, or maybe it has
- 3 happened in history, and that's why this is in there, to
- 4 abate that. So thank you.
- 5 COUNCIL MEMBER GREENE: Any other questions
- 6 from the Council?
- 7 Yes, Council Member Bedessem.
- 8 COUNCIL MEMBER BEDESSEM: Thank you.
- 9 Whoops. There we go. Just a couple of brief questions.
- I don't know if we've had criminal racketeering,
- 11 but I know we had at least one -- somebody in the witness
- 12 protection program. That was a previous -- but, anyway,
- 13 aside from that, I had a question about your response to
- 14 Stan's question regarding lifetime permit. I know -- I
- 15 mean, you clarified that lifetime is related to the
- 16 lifetime of the facility. But I remember when we first did
- 17 the municipal waste rules and converted to lifetime
- 18 permits, my recollection was we all joked about how it was
- 19 25 years, that the lifetime was 25 years. So has that
- 20 changed, or is it 25 years for industrial facilities as
- 21 well?
- MS. WEIKART: Mr. Chairman. The 25-year
- 23 for the lifetime, that's defined in statute for municipal
- 24 solid waste landfills. And so we don't have that
- 25 limitation for our other facilities. And so we've gone to

- lifetime through post-closure. There's no 25-year permit
- 2 term on it. It's also a gone-to for our transfer,
- 3 treatment, storage, our construction demolition landfills,
- 4 and our coal combustion residual landfills and surface
- 5 impoundments.
- 6 COUNCIL MEMBER BEDESSEM: Thank you for
- 7 clarifying. So 25 only applies to municipal solid waste --
- 8 MS. WEIKART: Correct.
- 9 COUNCIL MEMBER BEDESSEM: -- because it's
- 10 in statute.
- MS. WEIKART: Correct.
- 12 COUNCIL MEMBER BEDESSEM: Thank you. I
- 13 appreciate knowing that.
- 14 COUNCIL MEMBER GREENE: Any other questions
- 15 from the Council?
- 16 Thank you for your presentation.
- 17 Is there anyone present here in the room wishing
- 18 to testify in support of this rule package? Please come
- 19 forward and state your name and spell it for the record.
- Seeing none, I'll move on. Is there anyone
- 21 present on Zoom wishing to testify in support of the rule
- 22 package? Please state your name, and spell it for the
- 23 record.
- No? Is there anyone present here in the room
- 25 wishing to testify in opposition to the rule package?
