THIS Order arises out of the status conference conducted by Dennis Boal, presiding officer, for the Environmental Quality Council, on January 18, 2008.

1. Scheduling. After discussion with the parties, it was determined that the issues in this matter are legal in nature and can likely be determined without an evidentiary hearing. Therefore, the following schedule is set in this matter:

(a) Motions for Summary Judgment, with supporting memorandums of law and affidavits, shall be filled and served on or before February 25, 2008.

(b) Responses to Motions for Summary Judgment shall be filed and served on or before March 14, 2008.

(c) Oral argument on Motions for Summary Judgment is set for March 21, 2008 at 8:00 a.m., in Cheyenne, Wyoming. The exact location of the oral argument will be determined later. Each party will have fifteen minutes for oral argument.


(d) All documents shall be delivered no later than 4:00 p.m. on the above referenced date. For the purposes of this order, delivery shall mean that the recipient has the pertinent documents in hand. Delivery does not mean that the documents were placed in the mail or with a delivery service. The parties may deliver documents via fax or e-

mail, if prior arrangements have been made with the recipients and the original is mailed at the same time.

2. Objections to Status Conference Order.

The parties shall have ten days from the date of service to serve and file any objections to this Scheduling Conference Order.


