**ORDER APPROVING JOINT STIPULATION AND DISMISSING APPEAL**


The County of Sublette, Wyoming filed a Petition for Review of Final Determination and Request for Hearing before the Wyoming Environmental Quality Council (EQC) in Docket No. 09-5601 on March 23, 2009. The Wyoming Department of Environmental Quality (DEQ) filed its response on April 23, 2009. By its Scheduling Order of September 17, 2009, the EQC set the matter for hearing on March 11 and 12, 2010. On February 2, 2010 Sublette County and DEQ executed a Settlement Agreement which established the terms upon which the Parties agreed to dismiss the appeal. On February 8, 2010 Sublette County and DEQ filed a Joint Stipulation for Disposition and Dismissal of Appeal, incorporating the Settlement Agreement. Sublette County and DEQ are the only parties in this contested case.

The parties jointly stipulate and agree that the EQC should enter an Order approving, incorporating and binding them to their Settlement Agreement and dismissing Sublette County's appeal in Docket No. 09-5601. Chapter I, Section 11 of the DEQ Rules of Practice & Procedure provides for disposition of contested cases by stipulation or agreed settlement of the parties, upon approval of the EQC. Having reviewed the parties' Joint Stipulation, the Settlement Agreement and being fully advised in the matter,

IT IS HEREBY ORDERED that the Settlement Agreement between Sublette County and DEQ and their Joint Stipulation for Disposition and Dismissal of Appeal incorporating it is approved and incorporated herein and shall be binding upon them; and

IT IS FURTHER ORDERED that Sublette County's appeal in Docket No. 09-5601 is dismissed.


