**ORDER GRANTING THIRD STIPULATED MOTION TO EXTEND RESPONSE
FILING DEADLINE TO AUGUST 28, 2009**


The Council having been advised by a teleconference call, held on August 12, 2009, between the Presiding Officer Dennis Boal, Nancy Vehr, Legal Counsel for the Department of Environmental Quality (Department), and Bob Checketts, representing Kern River Gas Transmission Company (Kern River) that the parties have reached an agreement in this matter. The Parties informed the Council that the agreement has not yet been reduced to a writing signed by the parties but that the agreement has been drafted, that the parties are in good faith working towards the goals outlined in the draft agreement. That the agreement provides for an amendment to the current application, that said amendment has been received and analyzed by the Department and has been published for receipt of public comment. The Parties further advised the Council that at the conclusion of the public comment the Petitioner, the parties anticipate the issuance of an amended permit that will resolve the current appeal.

Wherefore the Council finds good cause to grant a short extension to the Department to respond to the petition of Kern River.

IT IS HEREBY ORDERED that the parties' Stipulated Motion to Extend Response Filing Deadline is hereby GRANTED until **August 28th, 2009**.

IT IS FURTHER ORDERED that the Parties shall file a Joint Settlement Agreement on or before 12:00 noon on August 28, 2009 or in the alternative DEQ shall file a response to the appeal with the EQC on or before **12:00 noon on August 28th, 2009**.


