ORDER

The Parties should provide the EQC office with a direct telephone number and an email address where they can be reached for the pre-hearing on or before November 5th, 2012. Failure to appear at the pre-hearing conference may result in dismissal from this case.

The Parties have all waived the presence of a court reporter so the hearing will be recorded electronically.

IT IS HEREBY ORDERED

1. The Parties shall appear for a short pre-hearing conference in this matter that will be conducted on Thursday November 8, 2012 at 11:00 a.m. via telephone conference call. The Parties shall provide the EQC office with a direct telephone number and an email address where

they can be reached for the pre-hearing on or before November 5, 2012. Failure to appear at the pre-hearing conference will result in dismissal from this case.

2. The Parties have waived the presence of a court reporter.


