Dear Ms. Madden:

Enclosed you will find a Notice of Violation (NOV) and Order, Docket Number 5207-13, issued under the provisions of W.S. 35-11-701(c).

The attached NOV includes a fuel delivery prohibition or "Red Tag" Order prohibiting the delivery of fuels to the underground storage tanks located at Wamsutter Phillips 66 until an operator's annual inspection (OAI) has been performed. You will also be required to re-take the International Code Council (ICC) W-6 Wyoming Storage Tank Operator's Exam within 90 days of the date of this NOV.

ANY APPEALS TO THE ENVIRONMENTAL QUALITY COUNCIL FROM THE ATTACHED ORDER MUST BE MADE IN WRITING WITHIN THE TEN (10) DAY TIME LIMIT PRESCRIBED BY W.S. 35-11-701(c). Chapter I, Section 3 of the enclosed Department of Environmental Quality Rules of Practice and Procedure sets forth the requirements for the initiation of appeal proceedings. You are urged to review all provisions of the attached Rules of Practice and Procedures as they relate to this action.

If you appeal this order and request a hearing, you must file two copies of your written petition. One copy of the petition should go to the Chairman of the Environmental Quality Council at Room 1714, Herschler Building, 1st Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. The second petition should be sent to the Director, Wyoming Department of Environmental Quality, Herschler Building, 4th Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail, return receipt requested.
