#### PROTESTANT'S PREHEARING MEMORANDUM

COME NOW THE PROTESTANTS, the FRIENDS OF BESSEMER MOUNTAIN, by and through counsel, LAWYERS AND ADVOCATES FOR WYOMING, and present their Prehearing Memorandum as follows:

#### **SUMMATION OF THE FACTS**

In July of 1989, Rissler & McMurry received a mining permit from the Department of Environmental Quality (DEQ). The permit was a ten acre exemption contained in the state's Environmental Quality Act (EQA). Through use of the exemption, Rissler & McMurry was able to begin mining without giving public notification or subjecting the area to environmental studies normally required by the EQA prior to granting a mining permit. Rissler & McMurry is now seeking to expand their mining operations from the original ten acres allowed by the exemption. Rissler & McMurry now wishes to expand mining operations to 110 acres through an application for small mining permit TFN 2 6/247.

The mining operation has been vigorously opposed by area residents, and has been the subject of numerous contested hearings, court cases, and appeals. In addition to the well publicized dispute between Rissler & McMurry and Mr. Rod Stalkup over the condemnation of an access road,

disputes developed regarding the issuance of an air quality permit for the mine. Rissler & McMurry sued Mr. Stalkup and others for libel and slander based upon their public opposition to the proposed mine. The Department of Environmental Quality (DEQ) issued the permit, but was criticized for not giving sufficient notice to allow opponents to voice their objections. After mining began, further complaints arose regarding the damaging effect of blasting on the Speas Fish Hatchery, and the dangerous build-up of silt in Speas Spring due to Rissler & McMurry's mining operations. Disputes developed regarding poor air quality and high dust levels caused by mining operations, and the proposed use of waste crude on the haul roads as a dust suppressant.

The most recent dispute concerned the area's designation as "rare and uncommon" pursuant to §35-11-112(a)(v) of the Environmental Quality Act. On April 24, 1992 the Environmental Quality Council (EQC) unanimously approved designation of several sections of Bessemer Mountain as "rare and uncommon." The EQC based its decision on the unique surface geological features, historical value, wildlife value, and scenic value of the area. Several potential mine sites have been proposed by individuals as alternatives to the rare and uncommon Bessemer Mountain area, but Rissler & McMurry has not indicated willingness to stop mining on Bessemer Mountain.

### **SUMMARY OF LEGAL ISSUES**

- 1. Whether the application for small mine permit TFN 2 6/247 is complete based on the requirements of the Wyoming Environmental Quality Act (Wyo. Stat. §35-11-101 through §35-11-1104).
- 2. Whether any part of the proposed operation, reclamation program, or the proposed future use is contrary to the law or policy of this state or the United States. Wyo. Stat. §35-11-406(m)(iii) (Supp. 1992).
- 3. Whether the proposed mining operation would irreparably harm, destroy or materially impair any area that has been designated by the council as a rare or uncommon area and having particular historical, archaeological, wildlife, surface geological, botanical or scenic value. Wyo. Stat. §35-11-406(m)(iv) (Supp. 1992).
- 4. Whether the proposed mining operation will cause pollution of any waters in violation of the laws of this state or of the federal government. Wyo. Stat. §35-11-406(m)(v) (Supp. 1992).
- 5. Whether the proposed operation constitutes a public nuisance or endangers the public health or safety. Wyo. Stat. §35-11-406(m)(vii) (Supp. 1992).
- 6. Whether information in the application shows that reclamation cannot be accomplished consistent with the purposes and provisions of the Wyoming Environmental Quality Act. Wyo. Stat. §35-11-406(m)(xi) (Supp. 1992).
- 7. Whether the applicant, Rissler & McMurry, has been and continues to be in violation of the provisions of the Wyoming Environmental Quality Act. Wyo. Stat. §35-11-406(m)(xv) (Supp. 1992).

- 8. Whether "site sensitive criteria" as discussed in <u>LeFaivre v.</u> EQC / DEQ, 735 P.2d 428 (Wyo. 1987) is applicable to the matter now before the Council.
- 9. Whether there is any other basis that justifies or requires denial of the permit.

### **UNCONTESTED FACTS**

- That Rissler & McMurry, Inc. filed for small mine permit TFN
   6/247 to mine in the Bessemer Mountain area near Casper, Natrona
   County, Wyoming.
- 2. That the proposed mine site in Rissler & McMurry's small mine permit application TFN 2 6/247 is very rare and uncommon having particular surface geological, historical, scenic, and wildlife value.
- 3. That letters and petitions have been received by the administrator of the Land Quality Division protesting the granting of said mining permit.
- 4. That the aforementioned protests generally concern dust, truck traffic, damage to wildlife habitat including Bald Eagle and Merlin Falcon habitat, damage to the area's scenic value, damage to Goose Egg or Speas Spring, damage to paleontological resources, and detrimental effects of mining on the Speas fish hatchery.
- 5. That Rissler & McMurry, Inc. has properly paid the required fee for the issuance of the mining permit.
- 6. That the affected land does not lie within 300 feet of any existing occupied dwelling, home, public building, school, church, community or institutional building, park, or cemetery.

#### PROPOSED FINDINGS OF FACT

1. That the application of Rissler & McMurry, Inc. for the issuance of small mine permit TFN 2 6/247 is not complete.

- 2. That Rissler & McMurry's proposed operation, reclamation program, and proposed future use is contrary to the law or policy of the State of Wyoming or the United States.
- 3. That Rissler & McMurry's proposed mining operation will irreparably harm, destroy, or materially impair an area that has been designated by the Council a rare and uncommon area having a particular historical, archaeological, wildlife, surface geological, botanical, or scenic value.
- 4. That Rissler & McMurry's proposed mining operations will cause pollution of waters in violation of the laws of the State of Wyoming or the federal government.
- 5. That Rissler & McMurry's proposed operation will constitute a public nuisance or endangers the public health and safety.
- 6. That Rissler & McMurry controls or has controlled mining operations with a demonstrated pattern of willful violations of subject matter and duration with such resulting in irreparable harm to the environment as to indicate reckless, knowing or intentional conduct.
- 7. That reclamation cannot be accomplished consistent with the purposes and provisions of the Wyoming Environmental Quality Act.
- 8. That Rissler & McMurry is in violation of the Wyoming Environmental Quality Act.
- 9. That reclamation of the mine site is impossible because the special nature of Bessemer Mountain will be destroyed by the cutting up and hauling away of the area's special features.

#### PROPOSED CONCLUSIONS OF LAW

- 1. That Rissler & McMurry has not complied with all requirements contained within the Wyoming Environmental Quality Act.
- 2. That the application for small mine permit TFN 2 6/247 is not complete based on the requirements of the Wyoming Environmental Quality

Act (Wyo. Stat. §35-11-101 through §35-11-1104).

That the application for small mine permit TFN 2 6/247 should not be granted.
