Proposed Rulemaking: Water Quality Rules and Regulations Chapters 15 and 25

The Water Quality Division of the Department of Environmental Quality is proposing revisions to Chapters 15 and 25 of the Water Quality Rules and Regulations and is requesting the Environmental Quality Council review the proposal and consider adoption of these rules at your July 8, 2015 hearing.

The proposed rule was presented to the Water and Waste Advisory Board (WWAB) at the following meetings: June 14, 2013; September 19, 2013; December 5, 2013; April 25, 2014; and July 25, 2014. Public comment periods accompanied the June 2013, April 2014, and July 2014 meetings. The WWAB has recommended approval of the draft rule. The enclosed draft rules include minor revisions requested during the July 2014 WWAB and minor revisions requested by the Attorney General's Office. These minor revisions do not change the purpose or intent of the proposed rule.
