Dear Mr. Lorenzon,

Thank you for your letter of June 9th.

You ask that I substantiate my allegations that there were omissions of surface owners and their addresses from Table III of Ms. Dunsmore's petition for designation of Sand Creek. Attached is a list of the owners in the area, as supplied to me by the Crook County Assessor's Office as well as a print out of their map. The assessor's office maintains addresses on all the property owners. Not only is the list submitted by Ms. Dunsmore inaccurate but it also appears that the maps submitted by Ms. Dunsmore are at the least inaccurate if not misleading in that the petition claims to be excluding private land while the map appears to include private land within the boundaries sought to be declared a Rare and Uncommon Area.

I trust the Crook County Assessor's records will substantiate my allegations. However, if additional evidence is needed, please let me know.
