**RST SAND AND GRAVEL/OBJECTORS--
SETTLEMENT**

The DEQ Permit issued to RST Sand and Gravel will include the following additional restrictions:

- a. As set forth in the permit application, the existing extraction site may be enlarged, but as an additional restriction only one new separate site would be operated for extraction at any time.
- b. The extraction operation for each such separate new site would be limited to a seven (7) year maximum and DEQ mandated reclamation would occur promptly after extraction operations cease for the site.
- c. The DEQ reclamation requirement for each such new extraction site will include the following wildlife protection: The reclamation plan text and Map - R3 in the application will be modified to include the following shallow shoreline wildlife enhancement features for any and all ponds in the northern half of the permit area: Final pond reclamation will include a shoreline transition area of at least fifteen feet wide with a slope of no more than 5:1; the pond slope commitment of 3:1 below the water line will remain as currently stated in the reclamation plan.

Based on the above, the appeal proceeding pending before the Wyoming Environmental Quality Council, Docket 16-4801, scheduled for a hearing on June 9, 2016, will be dismissed.
