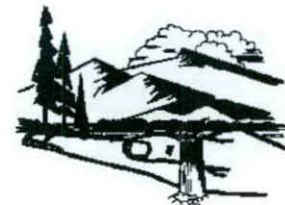

SUBJECT: Notice of Final Adoption of Air Quality Rules: Chapter 2, Chapter 3, Chapter 4, Chapter 5, Chapter 6, Chapter 7, Chapter 8, Chapter 11 (R-27)

Please consider this memorandum as notice of final adoption of revised air quality standards and regulations. Wyoming Air Quality Standards and Regulations (WAQSR), Chapter 2, Chapter 3, Chapter 4, Chapter 5, Chapter 6, Chapter 7, Chapter 8 and Chapter 11 have been revised in this rulemaking, and changes became effective on December 20, 2016. **Please discard existing contents of Chapter 2, Chapter 3, Chapter 4, Chapter 5, Chapter 6, Chapter 7, Chapter 8 and Chapter 11, and then insert the new editions of the chapters, which also can be accessed electronically at <http://soswy.state.wy.us/Rules/default.aspx>. The revised chapters include a forward, table of contents and body of regulations.**

Chapter 2, Ambient Standards, Section 6, Ambient standards for ozone, is amended, in part, to comply with portions of 40 CFR parts 50 and 53, and appendices to 40 CFR part 50, July 1, 2016.

Chapter 2, Ambient Standards, Section 12, Incorporation by reference, adopts by reference portions of 40 CFR parts 50, 53 and 58, and appendices to 40 CFR part 50, July 1, 2016.

Chapter 3, General Emission Standards, Section 9, Incorporation by reference, adopts by reference portions of 29 CFR part 1910 and 40 CFR parts 51 and 61, and appendices to 29 CFR part 1910 and 40 CFR parts 60 and 61, July 1, 2016.

Chapter 4, State Performance Standards for Specific Existing Sources, Section 6, Incorporation by reference, adopts by reference portions of 40 CFR part 60 and its appendices, July 1, 2016.

Chapter 5, National Emission Standards, Section 2, New source performance standards, is amended, in part, to comply with portions of 40 CFR part 60, and appendices to 40 CFR part 60, July 1, 2016.

Chapter 5, National Emission Standards, Section 4, Incorporation by reference, adopts by

reference portions of 40 CFR parts 60, 61, 63, and 70, and appendices to 40 CFR parts 60 and 63, July 1, 2016.

Chapter 6, Permitting Requirements, Section 3, Operating permits, is amended, in part, to comply with portions of 40 CFR part 98, July 1, 2016.

Chapter 6, Permitting Requirements, Section 4, Prevention of significant deterioration, is amended, in part, to comply with portions of 40 CFR part 98, July 1, 2016.

Chapter 6, Permitting Requirements, Section 14, Incorporation by reference, adopts by reference portions of 40 CFR parts 51, 52, 60, 61, 63, 70, 75 and 98, and appendices to 40 CFR parts 51, 58 and 60, July 1, 2016.

Chapter 7, Monitoring Regulations, Section 3, Compliance assurance monitoring (CAM), is amended, in part, to comply with portions of 40 CFR part 98, July 1, 2016.

Chapter 8, Nonattainment Area Regulations, Section 10, Incorporation by reference, adopts by reference portions of 23 CFR parts 450, 712 and 771, 40 CFR parts 50, 51, 60, 80, 81 and 93, 49 CFR part 613, and appendices to 40 CFR parts 51 and 60, July 1, 2016.

Chapter 11, National Acid Rain Program, Section 2, Acid rain program, adopts by reference portions of 40 CFR parts 72, 73, 74, 75, 76, 77 and 78, July 1, 2016.
