**ORDER OF CONTINUANCE AND SETTING DATE FOR FINAL HEARING**

THIS MATTER came before the Environmental Quality Council through a joint motion from Petitioner Dave's Asphalt and Respondent Wyoming Department of Environmental Quality, Water Quality Division, (Parties) seeking a continuance of this matter to allow for settlement negotiations. The Council finds that such continuance will not prejudice the Parties and is likely to lead to an efficient resolution of this matter.

However, this matter has been pending for a considerable time on the Council docket. Therefore, this matter will be set for final hearing on August 23, 2017 in Cheyenne WY at 9:00 a.m. unless otherwise ordered. The parties will be notified of the location of the hearing at a later time once the Council has finalized that decision. The parties shall timely conclude all discovery in this matter. Deadline for the identification of all exhibits and witnesses to be used or called at the time of final hearing is August 11, 2017. Exhibits shall be filed with each party and with the Council no later than 12:00 noon on August 15, 2017. Exhibits filed with the Council shall be done online with at least one paper copy brought to the final hearing to be included in the record by the court reporter. The exhibits will be identified and numbered by the online system as you enter them. As you are entering them make sure you check the "Final Exhibit" not the "Pleading Exhibit" box.
