ORDER

THIS MATTER having come before the Environmental Quality Council pursuant to the request of the Department of Environmental Quality for approval to seek bond forfeiture against Kings Point Energy Corporation, Permit No. 249C; said bond being a Certificate of Deposit with the Sumitomo Bank of California, certificate no. 123420 in the sum of Thirty One Thousand Dollars (\$31,000.00); the council having duly approved such bond forfeiture proceedings during their July 1983, Council meeting; it appearing that the requirements of W.S. 35-11-421 (bond forfeiture) have been satisfied; and no hearing having been requested by the operator; and the Council being otherwise fully advised in the premises;

IT IS HEREBY ORDERED:

1. That the aforementioned reclamation performance bond of Kings Point Energy Corporation, Permit No. 249C, in the sum of Thirty One Thousand Dollars (\$31,000.00) is forfeited to the Department of Environmental Quality, Land Quality Division, to be used by the Department for reclamation of all lands affected by said operation under permit No. 249C.

2. That any and all amounts not required for final reclamation of the lands affected shall be returned to the Kings Point Energy Corporation.
