Chapter 14 - Standards for Universal Waste

2007 Rule Revision Explanation

Introduction:

The proposed revisions in this Chapter are being initiated by changes to federal rules that have been promulgated by the Environmental Protection Agency (EPA) through the Federal Register Notices list below. Revisions being proposed in this package are comparable to the federal Resource Conservation and Recovery Act (RCRA) regulations. Other revisions are proposed to correct editorial errors.

The authority to revise the rules contained within Chapter 14 is provided by W.S. 35-11-503(d)(i).
