**STIPULATED JOINT MOTION FOR STAY**

---

COME NOW William P. Maycock ("Maycock"), Devon Energy Production Company, L.P. ("Devon"), and the State of Wyoming Department of Environmental Quality ("DEQ"), and for their STIPULATED JOINT MOTION FOR STAY, hereby move the Environmental Quality Council ("EQC") to stay the deadlines and hearing date contained in the March 1, 2007 SCHEDULING ORDER issued in the above captioned matter. In support of their motion, movants state the following:

1. The permit under appeal, WYPDES Permit No. WY0053899, will expire December 31, 2007, approximately two (2) months after the hearing scheduled in this matter and Devon's application for a renewal permit has been submitted to DEQ.

2. In response to Devon's application, DEQ has prepared a draft permit which provides that Devon's discharges under the permit will be contained in reservoirs except in the event of a 50-year/24-hour storm event. The parties are in the process of reviewing the draft permit and anticipate that it will be acceptable to all parties.

3. The parties expect that, after review of the draft permit is completed, Mr. Maycock will be prepared to withdraw his appeal of the current permit and there will be no need


for a hearing in this matter.

WHEREFORE, movants respectfully request that the EQC stay the hearing and all other deadlines identified in its March 1, 2003 SCHEDULING ORDER and remand the permits to the DEQ.
