Dear Mr. Parfitt:

We, the undersigned landowners and/or tenants living adjacent to or near the above referenced proposed facility, wish to formalize our objections to the granting of this permit, for the following reasons:

- We believe Mr. Dimick has acted in an unreasonable, imprudent, and unsafe manner in the operation of his current Shoshoni facility.
- Mr. Dimick is in violation of DEQ regulations in this facility regarding open dumping and open burning of waste.
- Mr. Dimick has failed to respond to a DEQ Notice of Violation (NOV) dated January 10, 2017 concerning the noncompliant operation of his Shoshoni facility.
- We believe that due to Mr. Dimick's failure to address and remedy the DEQ NOV, the citizens of Shoshoni are subject to real or potential hazards to public health and the environment.
- Given Mr. Dimick's continual noncompliance as outlined above, it is reasonable to believe he will operate his Riverton facility in a similar manner, thereby subjecting Riverton's citizens to real or potential hazards to public health and the environment.
- The proposed facility is located immediately adjacent to Riverton's recreational facilities, and near residential neighborhoods and playgrounds, further exposing these citizens to real or potential hazards to public health and the environment.
- We believe, given the nature of land ownership and transfer involved in this facility location, that monitoring and enforcing Mr. Dimick's compliance with applicable laws and DEQ regulations will be difficult if not impossible. Therefore, for these and other reasons not set forth herein, his permit should be denied.
