Certified Card (or other proof of mailing) to surface owner.

****NOTE**** If mailing is returned as undeliverable check for new address, if returned unclaimed submit the envelope containing the post office stamp depicting unclaimed, attempted to deliver, etc. with the certified card.

A copy of the County Assessors tax records proving current surface ownership.

****NOTE**** The tax records must contain the legal description on the NOITL.

If other information is needed, or problems found during adjudication of your NOITL, you will receive a letter from us in the near future.


