Wyoming State Mineral Lease 42804 (WSL04) is invalid as it violates the Rules and Regulations, Board of Land Commissioners, Chapter 22 Leasing of Bentonite, adopted pursuant to the authority granted in W.S. 36-6-101(b) which states:

(e) On lands in which the state owns less than the entire interest in the bentonite estate, a lease will be issued by the Board covering the state's interest independent of the other co-owners.
