Envtl. Prot. Agency, 862 F.3d 50 (D.C. Cir. 2017) (vacating portions of the Revisions to the Definition of Solid Waste)). EPA staff recognized in a conference call on August 1, 2017 that states such as Wyoming would want to wait to adopt the rule until the uncertainty and litigation surrounding the rule are resolved
