

Environmental Quality Council

Council (EQC) will consider proposed changes to Chapter 1 and Regulations (HWRR) brought forth by the Wyoming WDEQ, Solid and Hazardous Waste Division (Division) at 9:00 a.m. on January 19, 2019 in Room 127 of the Hathaway Building, 2300 North Lincoln, commencing at 9 a.m. (MST).

Division, pursuant to the authority vested in it by Wyoming Statute § 16-3-103(d), proposes to revise HWRR Chapter 1, General Regulations. The proposed revisions include updating sections (IBR) from the Code of Federal Regulations (40 CFR) incorporating EPA Rule Checklists 231, 232, and 234-239; not been adopted by reference, as exceptions; revising Appendix A) listing provisions more stringent and broader listed cross-reference tables between previous state rules to meet minimum substantive state statutory requirements § 16-3-103(a)(i)(G). The Department has evaluated the Wyoming Statute § 9-5-304, and interested persons may request the proposed rule package at the following address: Solid and Hazardous Waste Division, 200 W 17th Street, Casper, Wyoming. Comments, written and electronically filed comments, and the hearing with any modification to the HWRR proposed by the Council. Comments that focus on the previously received comments, and issues raised by the analysis will be accepted. The hearing will remain open beyond the close of the scheduled hearing. Any extensions will be posted on the Solid and Hazardous Waste Division website. The EQC, however, may close the record and make any amendments prior to concluding the hearing.

Comments contained in Docket #18-5102 may be submitted electronically at 5:00 p.m. (MST) on January 22, 2019. Written comments should be submitted to the Administrator, Solid and Hazardous Waste Division, 200 W 17th Street, Casper, WY 82002; faxed to 307-635-1784. The Division will file an electronic copy of comments received at least five (5) days before the public hearing.
