NOTICE IS HEREBY GIVEN THAT:

- 1. Pinnacle Energy Inc. (Pinnacle), is the owner/operator of coal bed methane (CBM) facilities located in portions of Sections 5 & 19, Township 53 North, Range 73 West (Sec. 5 & 19, T53N, R73W), Campbell County, Sec. 6, 31 & 34, T54N, R73W, Campbell County, Sec. 4, 7, 9, 18, 19 & 20, T55N, R73W, Campbell County, Sec. 1, T54N, R74W, Campbell County, Sec. 1, 13, 24 & 36 T55N, R74W, Campbell County, and Sec. 15, 28, 29 & 31, T54N, R79W, Sheridan County Wyoming. Between June 21, 2001 and March 13, 2006, WYPDES permits WY0043711, WY0043770, WY0043842, WY0043851, WY0046213, WY0046639, WY0046698, WY0047767, WY0051764, WY0052477, WY0053201 and WY0053961 were either renewed, issued and/or transferred to Pinnacle;
- 2. A Letter of Violation (LOV) was issued to Pinnacle on November 14, 2004 concerning the reporting of flow rates on discharge monitoring reports (DMRs) submitted to the Wyoming Department of Environmental Quality (DEQ), Water Quality Division (WQD). The LOV indicated that flow values for WYPDES permits WY0043711, WY0043842, WY0043851, WY0046213, WY0046698 and WY0047767 were reported incorrectly for the discharging outfalls for the 1st Semester, 2004. Flows reported on the DMRs indicated the monthly average flow rates were higher than the daily maximum and the units used to report the flow rates on the DMRs were something other than the required million gallons per day (MGD);
- 3. A LOV was issued to Pinnacle on December 30, 2005 concerning the reporting of flow rates on DMRs submitted to the WQD. The LOV indicated that flow values for WYPDES permits WY0043711, WY0043842, WY0043851, WY0046213, WY0046639, WY0046698, WY0047767 and WY0051764 were reported incorrectly for the discharging outfalls for the 1st Semester, 2005. Flows reported on the DMRs indicated the monthly average flow rates were higher than the daily maximum and the units used to report the flow rates on the DMRs were something other than the required MGD;
- 4. The WQD has reviewed the DMRs for WYPDES permits WY0043711, WY0043842. WY0043851, WY0046213, WY0046639, WY0046698, WY0047767, WY0051764, WY0052477 and WY0053201 for the 2nd Semester, 2005. Flows reported on the DMRs indicated the monthly average flow rates were higher than the daily maximum and the units used to report the flow rates on the DMRs were something other than the required MGD;

- 5. The WQD has reviewed the DMRs for WYPDES permits WY0043711, WY0043770, WY0043842, WY0043851, WY0046639, WY0046698, WY0047767, WY0051764 and WY0053961 for the 1st Semester, 2006. Flows reported on the DMRs indicated the monthly average flow rates were higher than the daily maximum and the units used to report the flow rates on the DMRs were something other than the required MGD;
- 6. Part I. of the WYPDES discharge permits concerning reporting of routine monitoring requires Pinnacle to submit DMRs to the WQD for review on a semi-annual basis throughout the life of the permits. Part I. of the WYPDES discharge permits concerning permit definitions states that MGD, for monitoring requirements, is defined as million gallons per day. By failing to report flow in terms of MGD, Pinnacle is in violation of the discharge permit requirements;
- 7. This Notice is being sent to you pursuant to W.S. 35-11-701(c)(i), which requires that in any case of the failure to correct or remedy an alleged violation, the director of the Department of Environmental Quality shall cause a written notice to be issued and served upon the person alleged to be responsible;

ORDER

BEFORE THE ENVIRONMENTAL QUALITY COUNCIL - STATE OF WYOMING

WHEREFORE IT IS HEREBY ORDERED THAT:

- 1. Pinnacle Gas Resources, Inc. (Pinnacle), when submitting discharge monitoring reports (DMRs) to the Wyoming Department of Environmental Quality (DEQ), Water Quality Division (WQD), shall report all flow rates for all permits issued to Pinnacle in terms of million gallons per day (MGD). Pinnacle shall determine the amount of water discharged from every outfall for each calendar day. The monthly average flow rate, in terms of MGD, shall be determined by calculating the total amount of water produced for an individual outfall and dividing that amount by the total number of days during the calendar month that water was discharged. The daily maximum flow rate, in terms of MGD, shall be determined by the maximum amount of water discharged during a calendar day for each month.
- Pinnacle shall submit, to the WQD, discharge monitoring reports (DMRs) with corrected monthly average and daily maximum flow rates for WYPDES permits WY0043711, WY0043842, WY0043851, WY0046213, WY0046698 and WY0047767 covering the 1st Semester, 2004.
- Pinnacle shall submit, to the WQD, DMRs with corrected monthly average and daily maximum flow rates for WYPDES permits WY0043711, WY0043842, WY0043851, WY0046213, WY0046639, WY0046698, WY0047767 and WY0051764 covering the 1st Semester, 2005
- 4. Pinnacle shall submit, to the WQD, DMRs with corrected monthly average and daily maximum flow rates for WYPDES permits WY0043711, WY0043842, WY0043851, WY0046213, WY0046639, WY0046698, WY0047767, WY0051764, WY0052477 and WY0053201 for the 2nd Semester, 2005.
- Pinnacle shall submit, to the WQD, DMRs with corrected monthly average and daily maximum flow rates for WYPDES permits WY0043711, WY0043770, WY0043842, WY0043851, WY0046639, WY0046698, WY0047767, WY0051764 and WY0053961 for the 1st Semester, 2006.
- 6. All DMRs shall be addressed to Brian R. Bohlmann, P.E., WYPDES Compliance & Enforcement Coordinator at the Wyoming Department of Environmental Quality, Water Quality Division, Herschler Building, 4th Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. The corrected DMRs shall be received by the WQD on or before November 15, 2006.

This ORDER is final unless, no later than ten (10) days after the date this notice is received, it is appealed by filing two written requests for a hearing before the Environmental Quality Council. If a hearing is requested, the first hearing petition shall be mailed to the Chairman, Wyoming Environmental Quality Council, Room 1714 Herschler Building, 1st Floor West, 122 West 25th St., Cheyenne, Wyoming 82002. The second petition shall be mailed to the Director, Wyoming Department of the Environmental Quality, Herschler Building, 4th Floor West, 122 West 25th St., Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail, return receipt requested.

NOTHING IN THIS NOTICE OF VIOLATION (NOV) AND ORDER shall be interpreted to in any way limit or contravene any other remedy available under the Environmental Quality Act, nor shall this NOV AND ORDER be interpreted as being a condition precedent to any other enforcement action.
