**MOTION FOR BOND FORFEITURE**

---

The Department of Environmental Quality, Land Quality Division, through the Wyoming Attorney General's Office, moves the Environmental Quality Council for an order forfeiting Yellowstone Landscaping, Inc.'s (Yellowstone) reclamation performance bond pursuant to Wyo. Stat. Ann. § 35-11-421(b). The Department states the following in support of this motion:

1. On December 22, 2005, the Department issued Limited Mining Operation (LMO) No. ET1336, also known as the Karst Pit to Wyoming Builders, Inc. The Karst Pit is a 3.9 acre gravel pit located in the SE1/4, SE1/4, Section 1, Township 54 North, Range 101 West, Lot 21 approximately five miles southwest of Ralston, Wyoming.
2. On September 28, 2012, Wyoming Builders, Inc. transferred LMO ET1336 to Yellowstone, which is owned by Daniel May.

3. Pursuant to Wyo. Stat. Ann. § 35-11-401(e)(vi)(B), Yellowstone posted a bond for the reclamation of the Karst Pit after mining operations ceased. Specifically, Yellowstone posted a four thousand dollar (\$4,000.00) Certificate of Deposit (No. 1277), issued by Big Horn Federal Savings Bank.

4. On June 9, 2014, the Wyoming Secretary of State administratively dissolved Yellowstone for delinquent taxes. Exhibit A. As a result, Yellowstone is no longer licensed to do business in the State of Wyoming.

5. The Department considers the limited mining operation at the Karst Pit to be abandoned as of June 9, 2014.

6. On August 29, 2018, the Department issued Yellowstone a Notice of Violation for LMO ET1336 (Docket No. 5868-18) for administrative and compliance issues, including failure to commence reclamation at the Karst Pit.

7. Yellowstone submitted its last annual report for the Karst Pit in December 2012. Since then, there has been no authorized mining at the Karst Pit. Yellowstone has failed to reclaim the mining site.

8. Based on the facts set out above, the Department determined that the reclamation performance bond should be forfeited.

9. On July 16, 2020, in accordance with Wyo. Stat. Ann. § 35-11-421(a), Director Todd Parfitt filed a Bond Forfeiture Recommendation with the Council, requesting approval to have the Attorney General's Office begin bond forfeiture proceedings against Yellowstone.

10. On August 19, 2020, the Council approved the Department's request to initiate bond forfeiture proceedings against Yellowstone.

11. On September 1, 2020, the Attorney General's Office sent notice of the forfeiture proceedings to Yellowstone, Daniel May, and Big Horn Federal Savings Bank by certified mail. Exhibit B.

12. The notice stated that Bond No. 1277, in the amount of four thousand dollars (\$4,000.00), would be forfeited unless Yellowstone made a written demand for a hearing within thirty days of receipt of the notice. Exhibit B.

13. The notice sent to Yellowstone was returned to the Attorney General's Office as undeliverable. Exhibit C.

14. The notice sent to Daniel May was returned to the Attorney General's Office as undeliverable. Exhibit D.

15. The notice sent to Big Horn Federal Savings Bank was received on September 3, 2020. Exhibit E.

16. On September 9, 2020, the Department's counsel contacted Daniel May at the phone number on record in the Department's permit file. During this phone conversation, Mr. May provided his personal mailing address of P.O. Box 661, Cowley, Wyoming 82420.

17. On September 9, 2020, the Attorney General's Office sent a second notice of forfeiture proceedings to Daniel May by certified mail to the new mailing address he provided. Exhibit F.


18. The second notice sent to Daniel May was returned to the Attorney General's Office as unclaimed. Exhibit G.

19. Neither the Attorney General's Office nor the Council has a record of a request for a hearing from Yellowstone, Daniel May, or Big Horn Federal Savings Bank.

20. If the operator does not demand a hearing before the Council within thirty days of receipt of notice, the Council shall order the bond forfeited. Wyo. Stat. Ann. § 35-11-421(b).

WHEREFORE, the Department respectfully requests that the Council enter an order forfeiting Yellowstone's reclamation bond totaling four thousand dollars (\$4,000.00), to be used by the Department to reclaim the mining operations developed under Limited Mining Operation No. ET1366.
