**THIS MATTER** came before the Environmental Quality Council on the Joint Motion and Stipulation for Consolidation of Cases submitted by Wyoming Outdoor Council, the Wyoming Department of Environmental Quality, Marathon Oil Company, Yates Petroleum Corporation, and Citation Oil & Gas Corp., being all the parties in the above-referenced cases, who moved to consolidate said cases.

**IT IS HEREBY ORDERED THAT:** The three cases, Docket Nos. 06-3815, 06-3816, 06-3817 are hereby consolidated into one case for the purpose of hearings and proceedings before the Environmental Quality Council and will be referred to as Docket No. 06-3816. The parties, Wyoming Outdoor Council, the Wyoming Department of Environmental Quality, Marathon Oil Company, Yates Petroleum Corporation, and Citation Oil and Gas Corp., shall have full rights of participation as parties in all aspects of all three cases.

**IT IS FURTHER ORDERED THAT:** The hearing for the above mentioned cases, which was scheduled for December 17-21, 2007, has been vacated and rescheduled to take place on January 28-February 1, 2008 commencing at 9:30 A. M. The Parties shall submit a Stipulation and Conforming Order if they desire to extend or modify any of the deadlines and cut-off dates set forth in the Scheduling Conference Orders and Amended Scheduling Conference Order entered in Docket Nos. 06-3815, 06-3816, 06-3817.


