Lorie Cahn, Water and Waste Advisory Board: Ms. Cahn noted the passages were worded in a confusing manner and that it was unclear how the 10 tons differentiation would affect the applicability of the Chapter.

Department Response: As discussed at the meeting, WDEQ/WQD has clarified the applicability of the Chapter by removing the paragraph at 2(a)(iii)(C) and by removing the reference to the statute so that the Chapter plainly states it applies to commercial waste treatment storage and disposal facilities.

Lorie Cahn, Water and Waste Advisory Board: Ms. Cahn noted that the phrase "and regulations" is included in the paragraph but has been stricken elsewhere in the Chapter.
