SUBJECT: Hearing Request for Land Quality Division Noncoal Rule Chapter 6

The Department of Environmental Quality (Department), Land Quality Division (LQD) is proposing revisions to LQD Noncoal Rules Chapter 6 – Financial Assurance and is requesting the Environmental Quality Council review the proposal and consider adoption of these rules at your February 22, 2023 hearing.

The LQD presented the proposed revisions to Noncoal Chapter 6 to the Land Quality Advisory Board (LQAB) during the following meeting dates as described below:
