AFFIDAVIT OF JENNIFER ZYGMUNT

Jennifer Zygmunt, being first duly sworn, deposes and states of her own knowledge that:

- 1. I am the Administrator of the Wyoming Department of Environmental

 Quality Water Quality Division. I have held this position since August 23, 2021.
- 2. I am over 18 years of age, I have knowledge of the facts stated herein either from my own personal knowledge or from Department records, and I am competent to testify thereto.
- 3. I oversee the Department's Water Quality Division and its staff, which regulates water quality within the state. *See* Wyo. Stat. Ann. §§ 35-11-301 through -312.
- 4. In May of 2022, the Department began working with Mountain Ventures regarding a potential permit for thirteen "glamping" sites at their Teton Village Resort.

On October 6, 2022, the Department issued the Notice of Coverage under the Small Wastewater Facility General Permit, Permit Number 2022-274, to Mountain Ventures for the small wastewater facility at their Teton Village Resort.

- 5. Following Petitioner's filing of their Appeal of Notification of Coverage Permit Number 2022-274, I conducted an internal review of Permit 2022-274 to determine if the Small Wastewater Facility General Permit that Permit 2022-274 had been issued under was in fact expired.
- 6. The internal review determined that the Small Wastewater Facility General Permit had been issued on June 19, 2017, and stated in its terms, that it expired within 5 years. On October 6, 2022, when the Notification of Coverage, Permit Number 2022-274, was issued, the general permit it was issued under was expired because it had been more than 5 years since June 19, 2017, and the general permit had not been renewed.
- 7. As a result of the general permit expiring, on December 7, 2022, I sent a letter to Mountain Ventures revoking Permit Number 2022-274.
- 8. As of this date, Mountain Ventures does not have a wastewater permit for the Teton Village Resort "glamping" sites.
