Opening Comments

Authorization of the Limited Mining Operation (LMO) was issued to Quality Landscape & Nursery, Inc. (QLN) on July 22, 2010. The LMO is located in Lots 1 thru 11, Block 1 (NE1/4NE1/4 of Section 14 T17N R84W) within the Town of Saratoga, Wyoming.

QLN signed Notice of Violation Settlement Agreement (NOVSA) for the NOV Docket No. 5970-19 on July 8, 2020. With the signing of this NOVSA, it has been established that there is no more minable areas within the legal description of LMO 1496ET. LQD has received QLN's annual reports and it has been reported that mined materials have been minimal. QLN continues to use the LMO for mixing imported materials and this activity has been documented in previous inspection reports. QLN has converted the LMO into a sales yard with commercial signs posted at the entrance of the LMO. Also, QLN constructed a commercial access from S 1st Street (**Photo #1**). These activities are not considered mining under W.S. § 35-11-401(e)(vi) or Noncoal Rules and Regulations, Chapter 10 Limited Mining Operations for Fifteen Acres of Affected Lands.

As agreed upon in the NOVSA, QLN has until July 8, 2022 to provide the approved site plan described in Section 7(c) of the agreement. If QLN does not fulfill the conditions set forth in Section 7(c), then QLN must proceed with developing an alternative plan to stabilize and reclaim LMO 1496ET in accordance with Section 7(d) of the agreement.

Compliance	Yes
April 2021 Field Inspection: LQD walked the perimeter of the mining operation to conduct the annual inspection. LQD continues to monitor and document the volume fluctuations of materials stockpiled at the LMO 1496ET. As noted in the photos, QLN has minimal materials stockpiled on the pit floor. The photo documentation illustrates the material stockpiles located on the pit floor and the volume fluctuations from July 14, 2020, September 24, 2020, and May 27, 2021 (Photos #2 thru #7).	
• Erosion Control	Yes
No erosion issues were noted during the inspection.

Inspection Topic	In Compliance
● Off-site/Permit Disturbance	Yes
Mining has occurred outside the legal description and the mining has resulted in material damage to the sheet pile retaining wall. The operator has removed material from the adjacent property. This compliance issue was conditionally resolved with the July 8, 2020 Settlement Agreement for NOV Docket No. 5970-19 (Photo #8).	
● Other	Yes
As requested, QLN has installed a fence and constructed a small berm at the foot of the sheet pile retention wall (Photos #9 & #10). QLN has posted danger signs around this wall.	
● Permit Signs	Yes
The LMO identification sign was in place at the entrance of the mine and posted the required information (Photo #11).	
● Roads and Culverts	Yes
QLN was granted authorization to construct commercial access on the south side of the LMO by the Wyoming Department of Transportation. The public access is from S 1st Street (State Highway 230) into the LMO (Photo #12). The materials excavated to construct the access have been stockpiled on the LMO. The material volumes will need to be recorded on the 2020-2021 Annual Report.	

Inspection Summary Comments

LQD will continue to monitor the material stockpile volumes and any material damage to the sheet pile retaining wall and property adjacent to the LMO. LQD would like to reiterate the NOVSA for the NOV, Docket No. 5970-19 deadline of July 8, 2022 to complete the requirements described in this agreement. If QLN does not complete these requirements, LQD will proceed with the forfeiture process and execute the option to recover any additional cost to reclaim the LMO.
