Re: Notice of Proposed Bond Forfeiture

Dear Mr. Woodward; Mr. and Mrs. Kraus; and U.S. Bank:

Pursuant to Wyoming Statute § 35-11-421, the Wyoming Department of Environmental Quality is seeking forfeiture of the following bonding/financial assurance instruments, which were deposited pursuant to the bonding provisions of the Wyoming Environmental Quality Act, Wyoming Statute §§ 35-11-101 to -2101 (the "Act"), as follows:

## Permit--LE-0306:

Paul M. Kraus and Julie A. Kraus Check No. 2623 \$5,000.00
 U.S. Bank Cashier's Check No. 3754506961 \$10,000.00

Cedar Rim Opal, LLC is the permit holder for license to explore 0306 (LE0306) and the related financial assurance instruments listed above. On March 8, 2023, the Wyoming Department

of Environmental Quality ("WDEQ"), Land Quality Division ("LQD") issued Notice of Violation (NOV), Docket Number 6200-23 for violation of the Act, including but not limited to Wyoming Statute § 35-11-901. Cedar Rim Opal, LLC failed to initiate and complete reclamation of the site as specified in the NOV and remains in violation of the Act.

Accordingly, the WDEQ now seeks forfeiture of the financial assurance instruments listed above, which were posted to ensure reclamation of this operation and performance of license conditions. On March 14, 2024, the WDEQ sought approval from the Wyoming Environmental Quality Council ("Council") to initiate bond/financial assurance forfeiture proceedings. On March 27, 2024, the Council approved WDEQ's request and issued its written order approving the request on April 8, 2024. A true and correct copy of the Council's April 8 *Order Granting Department's Request to Begin Bond Forfeiture Proceedings* is attached hereto.

Per Wyoming Statute § 35-11-421(b), the Wyoming Attorney General's Office is hereby notifying you that the Department seeks an order from the Council forfeiting the financial assurance instruments identified in this letter. The Council will order forfeiture of the financial assurance instruments in question unless you make a written demand for a hearing to the Council within thirty (30) days after receiving this notice. If the financial assurance documents are forfeited, the forfeited financial assurance instruments and funds will become the property of WDEQ according to Wyoming law.
