The Environmental Quality Council (EQC) having considered the parties' Stipulated Motion for Extension of Preliminary or Procedural Motions and Related Deadlines and Motion for Continuance finds and orders as follows:


1. Per the Scheduling Conference Order filed January 11, 2008, the deadline for preliminary or procedural motions is January 31, 2008; the deadline for responses to preliminary or procedural motions is February 20, 2008; and the deadline for replies to preliminary or procedural motions is March 6, 2008.
2. The parties desire additional time in which to file and brief preliminary or procedural motions, therefore,

**IT IS ORDERED** that the above deadlines be reset as follows:

- a. Deadline for preliminary or procedure motins is extended to February 8, 2008;
- b. Deadline for responses to preliminary or procedural motions is extended to March 12, 2008; and
- c. Deadline for replies to preliminary or procedural motions is extended to April 3, 2008.

**IT IS FURTHER ORDERED** that the hearing on preliminary or procedural motions is continued from April 7-8, 2008 to April 17-18, 2008.


