NOTICE OF ADDITIONAL AUTHORITY

Protestants Powder River Basin Resource Council et al. herein file a Notice of Additional Authority related to Respondent Department of Environmental Quality’s Motion to Dismiss (filed Feb. 7, 2008). Protestants submit Environmental Protection Agency (“EPA”), California State Motor Vehicle Pollution Control Standards; Notice of Decision Denying a Waiver of Clean Air Act Preemption for California’s 2009 and Subsequent Model Year Greenhouse Gas Emission Standards for New Motor Vehicles, 73 Fed. Reg. 12156 (Mar. 6, 2008) (attached as Exhibit 1) and Letter from Henry A. Waxman, Congress of the United States, House of Representatives to Stephen L. Johnson, Administrator, EPA (Mar. 12, 2008) (attached as Exhibit 2). These documents are relevant to Protestants’ argument in their Response to Basin Electric’s Memorandum in Support of the Department’s Motion to Dismiss at 10 n.11. As these documents show, EPA Administrator Stephen Johnson has conceded that global warming as a result of anthropogenic causes is occurring and is a threat to the public and the environment. 73 Fed. Reg. 12165-67. Furthermore, EPA assembled 60 to 70 staff members to comply with the Supreme Court’s ruling in Massachusetts v. EPA, and they developed a positive endangerment finding and proposed to regulate greenhouse gas emissions from motor vehicles. Although Administrator Johnson approved this proposal and sent it to the White House, once there, the process halted. Waxman Letter at 1.
