PREHEARING AND STATUS CONFERENCE ORDER



Participants in the conference included Mr. Michael Barrash, counsel for the Department of Environmental Quality (DEQ) and Matthew Joy, counsel for Yates Petroleum Corporation. Also attending the conference were Ms. Deborah Baumer, Office of Administrative Hearings, Mr. Joe Girardin, EQC paralegal and Jason Thomas, DEQ.

Upon the representations of the parties, it is understood that both parties desire additional time in which to attempt to reach a settlement.

**IT IS THEREFORE ORDERED THAT** the matter is continued until October 6, 2008, by which time the parties will file a status report with the EQC and attach either settlement documents or a proposed hearing schedule, including:

1. A schedule for discovery
2. Designation of experts
3. Dispositive motions
4. Date and time for prehearing conference
5. Potential dates and estimated duration of the hearing


