ORDER

The compensation of such reporter shall be paid as required by law and as ordered by the Council. The Council may direct any party or parties to assume the cost of the transcript." If the Parties do not file a waiver to this section, the Parties should equally pay the costs of the transcript.

- 1. The Parties shall appear for a short pre-hearing conference in this matter that will he conducted on Tuesday, January 27, 2009 at 1:00 p.m. via telephone conference call. The parties shall inform the EQC office of a telephone number where they can be reached for the pre-hearing on or before January 26, 2009. Failure to appear at the pre-hearing conference will result in dismissal from this case.
- 2. If the Parties have not filed a waiver on or before January 26, 2009 a court reporter will transcribe the hearing.
- 3. Each party shall assume one third of the cost of the transcript and court reporter.
