ORDER

If the Parties do not file a waiver to this section, the Parties should equally pay the costs of the transcript.

- 1. The Parties shall appear for a short pre-hearing conference in this matter that will he conducted on Tuesday, January 27, 2009 at 1:00 p.m. via telephone conference call. Failure to appear at the pre-hearing conference will result in dismissal from this case.
- 2. If the Parties have not filed a waiver on or before January 26, 2009 a court reporter will transcribe the hearing.
- 3. Each party shall assume one third of the cost of the transcript and court reporter.
