NOTICE OF COMPLIANCE

The Department of Environmental Quality (DEQ), Water Quality Division (WQD) issued a Notice of Violation and Order, Docket Number 3671-05 to KLT Gas, Inc. on February 1, 2005. The Notice was issued for failing to pay WYPDES permit fees as required by W.S. 35-11-701(c). KLT Gas, Inc. did not appeal the Notice of Violation and Order, and the Order became final.

The Notice of Violation and Order required KLT Gas, Inc. to pay all permit fees within 30 days of receiving the Notice, or provide documentation stating why the fees should not be paid. KLT Gas, Inc. has complied with the conditions in Docket Number 3671-05 by paying all permit fees and the DEQ finds that all terms of the Order have been satisfied.


ANY APPEALS TO THE ENVIRONMENTAL QUALITY COUNCIL FROM THE ATTACHED ORDER MUST BE MADE IN WRITING WITHIN THE TEN (10) DAY TIME LIMIT PRESCRIBED BY W.S. 35-11-701(c). Chapter I, Section 3 of the enclosed Department of Environmental Quality Rules of Practice and Procedure sets forth the requirements for the initiation of appeal proceedings. You are urged to review all of the provisions of the attached Rules of Practice and Procedures as they relate to this action.

To appeal this Order and request a hearing, you must file two (2) copies of your written petition. The first petition shall be mailed to the Chairman of the Environmental Quality Council at Room 1714, Herschler Building, 1st Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. The second petition should be sent to John V. Corra, Director, Wyoming Department of Environmental Quality, Herschler Building, 4th Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail, return receipt requested.

NOTICE OF VIOLATION

AND

ORDER

NOTICE IS HEREBY GIVEN THAT:

1. KLT Gas, Inc. is the owner of a WYPDES Permit allowing them to discharge water to the surface waters of the State of Wyoming. On September 3, 2004, KLT Gas, Inc. was mailed an invoice for WYPDES Permits WY0044091, WY0044067, WY0044075, WY0044083, WY0039454, WY0044041, and WY0044059. On December 1, 2004, KLT Gas, Inc. was mailed a second invoice for WYPDES Permit fees. WYPDES Permit fees totaling \$700.00 have not been paid for fiscal year 2004;
2. W.S. 35-11-312 states: "On July 1 of each year, the department shall assess an annual permit fee of one hundred dollars (\$100.00) for each national pollutant discharge elimination system permit and for each permit authorization held by any person under W.S. 35-11-301 during any portion of the preceding twelve (12) month period..."
3. By failing to pay all WYPDES Permit fees KLT Gas, Inc. has violated W.S. 35-11-312;
4. This Notice is being sent to you pursuant to W.S. 35-11-701(c)(i), which requires that in any case of the failure to correct or remedy an alleged violation, the director of the Department of Environmental Quality shall cause a written notice to be issued and served upon the person alleged to be responsible.

ORDER

BEFORE THE ENVIRONMENTAL QUALITY COUNCIL-STATE OF WYOMING

WHEREFORE IT IS HEREBY ORDERED THAT KLT GAS, INC. SHALL:


1. Within thirty (30) days of the receipt of this notice, KLT Gas, Inc. shall pay WYPDES Permit fees totaling \$700.00.
2. Within thirty (30) days of the receipt of this notice, provide documentation that the facility was no longer active as of March 4, 2004. Additionally, fill out and mail in the Notice of Termination (NOT) which can be downloaded at the following DEQ link <http://deq.state.wy.us/wqd/stormwater.asp>.
3. Payment to the DEQ shall be by check made payable to the Wyoming Department of Environmental Quality, Water Quality Division. The payment and/or NOT shall be sent to: Brian R. Bohlmann, P.E., WYPDES Compliance Program Principal, Department of Environmental Quality, Water Quality Division, Herschler Building, 4th Floor West, 122 W 25th St, Cheyenne, Wyoming, 82002. The check or NOT should reference Docket Number 3671-05.

4. If item 1 or 2 is complied with, or an appropriate combination of 1 and 2 is complied with, this will constitute full compliance with this order.


THIS ORDER is final unless, no later than ten (10) days after the date this Notice is received; it is appealed by filing two written petitions for a hearing before the Environmental Quality Council. If a hearing is requested, the first petition shall be mailed to the Chairman, Wyoming Environmental Quality Council, Room 1714, Herschler Building, 1st Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. The second petition shall be mailed to John V. Corra, Director, Wyoming Department of Environmental Quality, Herschler Building, 4th Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail, return receipt requested.

NOTHING IN THIS ORDER shall be interpreted to in any way limit or contravene any other remedy available under the Environmental Quality Act, nor shall this Order be interpreted as being a condition precedent to any other enforcement action.
