The regulation further requires that such information be made available in at least one location in the affected air quality control region, and that the public be allowed a period of thirty (30) days in which to submit comments.

Notice is hereby given that the State of Wyoming, Department of Environmental Quality, Division of Air Quality, proposes to approve a request by the following applicant to construct a new source in Carbon County.

The applicant has requested permission to construct an underground coal mine and industrial gasification and liquefaction (IGL) plant that will produce transportation fiels and other products. The underground coal mine is expected to have a maximum production rate of 8,700 tons per day (TPD) of coal or approximately 3.2 million tens per year (MMTPY) of coal as feed to the IGL Plant. The plant will gasify coal to produce synthesis gas (syngas) to produce the following products: 18,500 barrels per day (bpd) of gasoline, 42 tons per day of sulfur, 198 million standard cubic feet per day (MMscfd) of carbon dioxide (GO2), and 712 tons per day of coarse slag. The Medicine Bow IGL Plant is located in Section 29, T21N, R79W, approximately eleven (11) miles, southwest of Medicine Bow, in Carbon County, Wyoming, A copy of the permit application and the agency's analysis is available for public inspection at the Carbon County Clerk's Office, Rawlins, Wyoming. In accordance with the Americans with Disabilities Act, special assistance or alternate formats will be made available upon request for individuals with disabilities.
