**STATUS REPORT AND STIPULATION FOR DISMISSAL**

Appellant Quarter Circle Five Ranch, LLC (QC5), Permittee Newpark Environmental Services (Newpark), and the Wyoming Department of Environmental Quality, Water Quality Division (DEQ) submit the following Status Report and Stipulation for Dismissal pursuant to the January 18, 2006 Order Requiring Status Report filed herein:

1. QC5 recently reached a settlement with Newpark in the above-captioned matter, in which QC5 has agreed to withdraw its appeal, with the parties to bear their own costs and attorney fees. Accordingly, QC5 hereby withdraws its appeal, and QC5, Newpark and DEQ request that the Environmental Quality Council enter the attached Order to dismiss the appeal, with the parties to bear their own costs and attorney fees.




