ORDER

On December 27, 2013 at 3:45 p.m. the Council held a scheduling conference in the above entitled matter. The Presiding Officer was councilman Dr. David Bagley. Petitioners present were Dennis Herrick, Jonathan Phillips, Lisa Whetstone, Jo Ann and Donnie Kenyon and on behalf of the Town of Mills was Kevin O'Hearn, Marrolyce Wilson and Rob Hand. Present on behalf of the Department of Environmental Quality (Respondent) was Senior Assistant Attorney General Mike Barrash and Jeremy Gross. Present on behalf of the Third Party Respondent Anchor Environmental was Jim Skovgard. Staff present for the Council were Jim Ruby, Joe Girardin and John Knepper. The hearing was transcribed by a court reporter.

Petitioners not present and hereby dismissed from this matter for failure to appear as ordered are Jim and Diane Siri.

IT IS HEREBY ORDERED

- 1. The Parties have until January 8th, 2014 to designate their witnesses both lay and expert and expert reports.
- 2. The Parties shall file Written Interrogatories, Requests for Production of Documents and other discovery by January 17, 2014. Responses to discovery shall be completed no later than January 31, 2014. The deadline for depositions will be February 11, 2014.
- 3. Hearings on any dispositive motions will be heard on the same day as the date for final hearing prior to the beginning of the final hearing.
- 4. Exhibits shall be filed by each party and with the Council no later than 12:00 noon on February 20, 2014. Exhibits should be provided to the council in both digital and paper form.
- 5. The Petitioners shall number their exhibits using their last name and then 1,2,3,4. Dennis Herrick shall file his as Herrick 1,2,3,4 etc. Lisa Whetstone shall number her exhibits Whetstone 1,2,3,4 etc. Jonathan Phillips shall number his exhibits in cooperation with the Town of Mills, and shall be numbered Mills 1,2,3,4 etc. Mr. and Mrs. Kenyon shall number their exhibits Kenyon 1,2,3,4 etc. The DEQ shall number their Exhibits DEQ 1,2,3,4 etc. Anchor Environmental shall number their exhibits Anchor 1,2,3,4 etc.
- 6. The Petitioners shall file preliminary statements of issues no later than 12:00 noon January 10, 2014.

- 7. The DEQ may file a bench brief outlining the legal issues and legal support by February 13, 2014. Any responses to the brief shall be filed by the Petitioners and Anchor by February 18, 2014.
- 8. The Parties estimate that this matter shall take approximately $\frac{1}{2}$ day to present evidence.
- 9. The final hearing in this matter shall commence at 1:30 p.m. on February 25, 2014. The hearing shall be held at the Union/University Building, 951 North Poplar St. Casper Wy.
