<u>ORDER</u>

- Hearings on any dispositive motions will be heard on the same day as the date for final hearing 3. prior to the beginning of the final hearing.
- Exhibits shall be filed by each party and with the Council no later than 12:00 noon on January 7, 4. 2014. Exhibits should be provided to the council in both digital and paper form. If an exhibit cannot be provided in digital form than 8 copies of the exhibit shall be provided to the council.
- 5. The Petitioners shall number their exhibits using their last name and then 1,2,3,4. Brian Waitkus shall identify his as Waitkus 1, 2,3,4 etc. Cotton Holdings and Kathryn Cotton shall identify their exhibits as Cotton 1,2,3,4. The DEQ shall number their Exhibits DEQ 1,2,3,4 etc. Mountain Cement Company shall number their exhibits MCC 1,2,3,4 etc.
