ORDER OF FORFEITURE

THIS MATTER having come before the Wyoming Environmental Quality Council pursuant to request of the Department of Environmental Quality for approval to seek bond forfeiture against H.C. Trucking Company, Inc., of P.O. Box 909, Gillette, Wyoming 82719, in regard to Permit No. 32ET for its unreclaimed sand and gravel mine located in Campbell County, Wyoming; the bond for which is a corporate surety bond, No. 90-98-070, issued by the Fidelity and Deposit Company of Baltimore, Maryland, in the amount of six hundred dollars (\$600.00); the Council having approved the initiation of these proceedings during its meeting of December 16, 1986, and notice having been mailed as required by law on February 11, 1987; but no hearing having been requested within thirty days of receipt of the notice on February 19, 1987; with it appearing from the record that all requirements of Wyoming Statute 35-11-421 have been satisfied by the Department in regard to bond forfeiture; and the Council being otherwise fully advised in the premises:
