The Department of Environmental Quality (DEQ), by and through its attorney, John S. Burbridge, Senior Assistant Attorney General, informs the EQC of the current status of the above captioned matter and hereby requests that a response in the matter be stayed for the following reasons:

- This matter has been discussed with Mary A. Throne, attorney for Fidelity Exploration & Production Co. (Appellant). The issues contained in the appeal have been nearly resolved to the satisfaction of the Appellant and additional modifications to the permit are pending and have been agreed to in principle.
- 2. The agreed resolution between the DEQ and Appellant requires a major modification of the permit and, as such, Appellant has agreed to file additional paperwork with the DEQ. As a result, public notice had to be completed before issuance of the new permit and its conditions could occur.
- 3. Public notice has passed and the permit is to issue after routing for signature scheduled for April 28, 2006. Once the permit is in Fidelity's possession, the parties
