

Wyoming Environmental Quality Council

The Wyoming Environmental Quality Council (the Council) will consider proposed revisions to the Wyoming Department of Environmental Quality/Water Quality Division (the Department) Water Quality Rules and Regulations at a public hearing to be held on July 8, 2015 at the Herschler Building, Room 1699, 122 W 25th Street, Cheyenne, Wyoming, commencing at 10:00 a.m. (MST).

The Department, pursuant to the authority vested in it by the Environmental Quality Act, Wyoming Statute (W.S.) § 35-11-302, proposes to revise the Water Quality Rules and Regulations by moving the contents of Chapter 15, Appendix C to new Appendix B of Chapter 25, by updating design requirements and correcting inconsistencies in Chapter 25, and by reserving Chapter 15. The revised rules meet minimum substantive state statutory requirements in accordance with W.S. § 16-3-103(a)(i)(G). The Department has evaluated the revised rules in accordance with W.S. § 9-5-304, and interested persons may inspect a copy of that evaluation and the proposed rule package at the following address: Department of Environmental Quality, Water Quality Division, Herschler Building, 4th Floor, 122 W. 25th Street, Cheyenne, Wyoming. The Council will begin accepting comments on the proposed revisions beginning May 5, 2015. In order for the Department to file the response to comments, written comments should be received no later than 5:00 p.m. (MST) on June 24, 2015. Written comments should be sent to the Wyoming Department of Environmental Quality/Water Quality Division, 122 West 25th Street, Herschler Building - 4W, Cheyenne, Wyoming, 82002 or faxed to (307) 777-5973. Email comments will not be considered under Docket #15-3101. The Department will file a response to comments with the Council prior to the July 8, 2015 hearing. The Council has scheduled a public hearing on July 8, 2015. The Council will consider the proposed rules, written comments, and the response to comments along with any modifications proposed by the Department to the draft rules. At the public hearing, oral statements that focus on the written comments, the Department's analysis of comments and issues raised by the analysis will be accepted. The Council will determine if the record will remain open beyond the close of the scheduled hearing. The Council, however, may close the record and make a final decision regarding the rules at the conclusion of the hearing. Those who wish to comment on the proposed revisions should submit comments according to the schedule above.

Any person wishing to use a digital presentation during their testimony before the Council must provide a digital copy to the Council no less than three (3) days prior to the hearing unless they contact the Council and request an extension for good cause. Failure to submit a timely digital copy will result in the person not being allowed to use the presentation during their testimony.
